The public KS-CPOST Commission meeting was held via Microsoft Teams Meeting and was called to order at 3:05 pm by Chair Brandon J. Johnson. Executive Director Gary Steed conducted a roll call of commissioners in attendance, along with KS-CPOST and KLETC staff in attendance listed above.

KS-CPOST Chief Counsel Michelle Meier led the discussion on the process of filling the vacancy of the KS-CPOST Executive Director position due to the upcoming retirement of Executive Director Steed. She presented to the Commission the history of the Executive Director position and a draft of the position announcement.

After making changes to the draft, the Commission finalized the position announcement, set dates for the application deadline and selection meetings, and chose the organizations and associations in which to post the position announcement.

Motion 2021 M 10 was made by Chair Johnson that a selection committee will be appointed and that the committee will present no less than two and no more than three names to the full Commission for consideration. The motion was seconded by Commissioner Presley and passed unanimously.

Motion 2021 M 11 was made by Commissioner Jones to have a selection committee consisting of Executive Director Beck, Executive Director Steed, the chair, a chief, a sheriff, and a member of a state organization being either Commissioner Thompson or Commissioner Jones. The motion was seconded by Commissioner Hooper and passed unanimously.

Motion 2021 M 12 was made by Commissioner Bauer to have a selection committee consisting of Executive Director Beck, Executive Director Steed, Chair Johnson, Chief Hooper, Sheriff Presley, and Superintendent Jones. The motion was seconded by Commissioner Soldan and passed unanimously.

Motion 2021 M 13 was made by Chair Johnson to adjourn the meeting at 4:31 pm. The motion was seconded by Commissioner Presley and passed unanimously.
