The public KS-CPOST Commission meeting was called to order by Chairman John Whitmer with a roll call of commissioners in attendance as listed above. KS-CPOST and KLETC staff in attendance as listed above.

Approval of minutes

A motion (2016 M 04) was made by Commissioner Powell and seconded by Commissioner Thompson to approve the minutes of the August 31, 2015 commission meeting. Motion passed unanimously.

Commissioner Schoen made a motion (2016 M 05) to approve the minutes of the November 24, 2015 commission meeting. The motion was seconded by Commissioner Jones and passed unanimously.

A motion (2016 M 06) was made by Commissioner Herrig and seconded by Commissioner Jarboe to approve the minutes of the May 5, 2016 commission meeting. Motion passed unanimously.

KS-CPOST Director's Report

Executive Director Gary Steed presented his report which included a briefing on the budget, the new Central Registry which is to go online the beginning of November, and statistics on the current Central Registry and KS-CPOST cases.

KLETC Director's Report

Director Pavey of the Kansas Law Enforcement Training Center presented his report which included a financial review, names of employees recently hired at KLETC, skill development training for responding to misconduct in schools, completion of the new maintenance building, and training summary statistics.

The Deputy Assistant Director at KLETC, Ron Gould, updated the commission on the continuing training on Blue Courage, and Fair and Impartial Policing.

Jonathan Morris, Program Manager at the Law Enforcement Leadership Academy, gave a presentation and provided a video on the Leadership Academy and its supervisor and command level school programs.

Director Pavey briefed the commission on the final stages of the Amber Alert video and on the KLETC badge being trademarked.

New Business

Commissioner Herrig made a motion (2016 M 07) to nominate Commissioner Fleming for the Investigative Committee, which was seconded by Commissioner Jones. The motion passed unanimously.

Commissioner Herrig made a motion (2016 M 08) to nominate Commissioner Bauer for the Investigative Committee to fill Commissioner Jarboe's vacancy in January, 2017. Commissioner Powell seconded the motion and it was passed unanimously.

A motion (2016 M 09) was made by Chairman Whitmer to nominate Commissioner Jones for the Curriculum Committee. This motion was seconded by Commissioner Mellor and passed unanimously.

KLETC Instructor Becky Miller presented a resolution approving the addition of stalking as a separate class within the full-time basic training course curriculum and reducing the allocated time to domestic violence. Chairman Whitman made a motion to approve this resolution (R-2016 001) and it was seconded by Commissioner Jones. The resolution passed unanimously.

A second resolution was brought forth to approve the addition of one hour to crisis management strategies within the full-time basic training course curriculum and the reduction of time to death investigation by the same. A motion to pass this resolution (R-2016 002) was made by Chairman Whitmer. It was seconded by Commissioner Herrig and passed unanimously.

Chairman Whitmer made a motion to pass a resolution (2016 R 003) authorizing the KS-CPOST director to review training submitted towards satisfaction of an officer's in-service training requirement for ultimate approval pursuant to K.S.A. 74-5607a(b). The motion was seconded by Commissioner Mellor and passed unanimously.

Upon motion (2016 M 10) made by Commissioner Herrig and seconded by Commissioner Powell, the meeting was adjourned at 1:33 pm by a unanimous approval.
