KS-CPOST Commission meeting, a public meeting conducted by conference call on this date, was called to order on September 17, 2012 by Chairman Moses with a roll call of commissioners in attendance as listed above. It was noted Commissioner Jarboe was absent but a quorum was in attendance. Chairman Moses explained the reason for the meeting was to approve or adopt the KAR's. He requested a brief overview of them by KS-CPOST Counsel Eric Williams.

Changes to the KAR's were reviewed beginning with changes to Article 2 106-2-1, the definitions, that were required by the changes to the training act due to the passage of Senate Bill 424. He reviewed the changes to Article 3 Officer Certification Standards. He noted that 106-1-1 through 106-1-8 permanently revoke the old regulations of KS-CPOST. Sections 107-1-1 through 107-1-5 along with 107-2-1 and 107-3-1 permanently revoke the old KLETC regulations.

Counsel Williams explained the process of review and approval of the regulations which included: publication of the regulations in the Kansas Register by the Secretary of State; approval by the Kansas Department of Administration and the Attorney General's office; a public hearing on the permanent

regulations held in the KS-CPOST office at 9 am on September 5, 2012; advertised by published notice in the Kansas Register; all law enforcement agencies in Kansas were notified of the proposed permanent regulation changes and advised they were posted on the KS-CPOST web site for their review along with the temporary regulation changes.

In addition during the 60 day comment period preceding the adoption of proposed regulations Executive Director Steed appeared before numerous professional law enforcement organizations in Sedgwick County, Shawnee County and Johnson County to explain the changes and answer questions. All but one comment received by the agency resulted in changes to the proposed regulations that were not substantive but rather clarified meanings.

The agency's temporary regulations are set to expire October 28, 2012. If these regulations are adopted by the Commission and submitted to the Secretary of State no later than October 1, 2012 they can be published on October 11, 2012 in the Kansas Register as permanent regulations of KS-CPOST. There will be no gap between the temporary and the permanent regulations.

Upon motion by Commissioner Keller, seconded by Commissioner Garcia to adopt the permanent regulations: K.A.R. 106-2-1; K.A.R. 106-2-2; K.A.R. 106-2-2a; K.A.R. 106-2-3; K.A.R. 106-2-4; K.A.R. 106-3-1; K.A.R. 106-3-2; K.A.R. 106-3-4; K.A.R. 106-3-5; K.A.R. 160-3-6 and K.A.R. 106-4-1 was carried by unanimous roll call vote: Commissioner Bardezbain – aye; Commissioner Bundy – aye; Commissioner Bush – aye; Commissioner Garcia – aye; Commissioner Jones – aye; Commissioner Keller – aye; Commissioner Miller – aye; Commissioner Pierce – aye; Commissioner Schoen – aye; Commissioner Thompson – aye and Commissioner Moses – aye.

Upon motion by Commissioner Keller, seconded by Commissioner Bardezbain to adopt the permanent regulations revoking the following: K.A.R. 106-1-1; K.A.R. 106-1-2; K.A.R. 106-1-3; K.A.R. 106-1-4; K.A.R. 106-1-5; K.A.R. 106-1-6; K.A.R. 106-1-7; K.A.R. 106-1-8; K.A.R. 107-1-1; K.A.R. 107-1-2; K.A.R. 107-1-3; K.A.R. 107-1-4; K.A.R. 107-1-5; K.A.R. 107-2-1; and K.A.R. 107-3-1 was carried by unanimous roll call vote: Commissioner Bardezbain – aye; Commissioner Bundy – aye; Commissioner Bush – aye; Commissioner Garcia – aye; Commissioner Jones – aye; Commissioner Keller – aye; Commissioner Pierce – aye; Commissioner Schoen – aye; Commissioner Thompson – aye and Commissioner Moses – aye.
