The public KS-CPOST Commission meeting was called to order on December 10, 2014 at 9:13 am by Chairman John Whitmer with a roll call of commissioners in attendance as listed above. KS-CPOST and KLETC staff in attendance as listed above made self-introductions.

Approval of minutes

Motion was made by Commissioner Sage, seconded by Commissioner Schoen to approve the minutes of the June 11, 2014 meeting. Motion passed unanimously.

KS-CPOST Director's Report

Executive Director Gary Steed presented his report which included a briefing on the budget, Central Registry statistics and investigations statistics.

Director Steed led a discussion of licensing fees. Commissioner Schoen made a motion (2014 M 08) authorizing staff to commence work towards licensing fees which was seconded by Commissioner Thompson. The motion passed unanimously.

Legal Counsel Eric Williams briefed the commissioners on the revisions to K.S.A. 74-5607(g)(1), K.S.A. 74-5611a(f), KS.A. 74-5622(b) and K.S.A. 74-5616(f). These changes are currently in the Office of the Revisor. The legislation changes will be introduced into legislation by Chairman Whitmer and Representative Carmichael.

Legal Counsel Eric Williams presented a request from the Juvenile Justice Authority (JJA) for support of their action to remove JJA investigators from the definition of law enforcement officers under the Training Act. Following discussion Commissioner Whitmer made a motion, seconded by Commissioner Jones (2014 M 09) which passed with eight (8) votes and one (1) abstention.

Presentation material from the director's report was distributed.

Chairman Whitmer called for a 10 minute break.

Chairman Whitmer reconvened the meeting at 10:45 am.

KLETC Directors Report

Director Pavey of the Kansas Law Enforcement Training Center presented his report which included a financial review, meeting with the Attorney General's Office regarding funding, changes in staffing, losses in the maintenance building fire, and a strategic plan draft. The Commission was also briefed on KLETC'S two hottest topics, Crisis Intervention Team Training and Bias Based Policing. Presentation material from the director's report was distributed.

New Business

A discussion was led by Director Steed to fill the open positions on the four KSCPOST committees.

Chairman Whitmer made a motion (2014 M 10) to nominate Commissioner Shoen for the Hearing Committee, which was seconded by Commissioner Bush. The motion passed unanimously.

Chairman Whitmer made a motion (2014 M 11) to nominate Commissioner Sage for the Investigative Committee. The motion was seconded by Commissioner Bush and passed unanimously.

Commissioner Keller made a motion (2014 M 12) to nominate Commissioner Powell for the Curriculum Review Committee, which was seconded by Chairman Whitmer. The motion passed unanimously.

Commissioner Keller made a motion (2014 M 13) to nominate Commissioner Powell for the Municipal Reimbursement Committee. The motion was seconded by Chairman Whitmer and passed unanimously.

Upon motion by Commissioner Powell and seconded by Commissioner Sage, the meeting was adjourned at 11:40 pm by unanimous approval.
